- The amount of the Trust shall be maintained properly as and when the transactions occur and shall be closed every year commencing from the first day of June and ending on the last day of May every year, and the first of such closing shall be on 31st May, 1980.
- The accounts of the Trust shall be audited 5. every year by a Chartered Accountant.

- The net income arising out of the Trust 7. properties, whether movable or immovable after meeting all the expenses shall be utilised for all or any of the aforesaid objects in India as the Trustees may decide.
- The Trustees have got right to spend, advance or invest in institutions engaged in the work of ameliorating the distress of suffering men, women and children, irrespective of caste, creed or community.

- 10. The Trustees shall be entitled to change one form of investment into another as they may deem fit and proper.

- 11. The Trustees shall be entitled to appoint such starf for administering the Trust properly on such terms as they may decide and shall have the power to dismiss the persons so appointed.
- 12. Any two trustees shall be entitled SOINTLY to operate the bank accounts of the Trust.
- 13. All amounts received shall be deposited with the bankers of the Trust regularly, after keeping only small amounts to meet day to day expenses.
- 14. The Trustees are empowered to borrow money with or without security and utilise the same for the benefit of the Trust and pay interest on such borrowings and the Trustees shall repay as early as possible such borrowings out of the income and also from out of the donations received.
- 15. The funds of the Trust including the interest shall not be utilised for any other purpose other than the objects mentioned herein and the conditions will bind the Trustees.
